THAMES VALLEY POLICE UPDATE (Agenda Item 5)

There were no representatives from TVP present.

Further to resolution 2245 it was confirmed that a fence and electric gate has been erected at the Sandhurst School Sports Car Park. This has been welcomed by TVP.

DRUGFAM UPDATE (Agenda Item 6)

There was no representative from Drugfam present.

TVP CONTRIBUTION TO SRA MAGAZINE (Agenda Item 7)

PC Campion was thanked for his excellent article that was published in the latest SRA magazine.

PARKING ISSUES RAISED BY RESIDENTS (Agenda item 8)

Bracknell Forest Council have confirmed that enforcement officers have been operating in Sandhurst. There have been fines issued to vehicles parked on double yellow lines and vehicles parking over the designated time limit in shopping areas.

SPEEDWATCH (Agenda item 9)

The Committee were advised that Speedwatch sessions may now take place. The sessions would need to be conducted using social distancing

that a generic message warning residents of the potential issues with cold callers is placed on the local facebook page "We love Sandhurst".

The group were informed that the COVID 19 Lateral Flow Testing is continuing in the Community Hall and that appointments are not necessary. A question was raised about why STC have two testing sites. It was confirmed that the LFT are for people with no symptoms and that the Pyes Acre site is for people displaying symptoms of COVID 19.

The group were informed that STC have seen an increase in anti-social behaviour over the last few months. Incidents include vandalism, deliberate fires and litter. All incidents are reported to TVP.

Following the recent unauthorised encampment at Shepherd Meadows it was confirmed that the vehicles that were trespassing were moved on the same day. Substantial amounts of rubbish were left behind. A local resident gave up his time to assist with the clearing of the site.

The group were informed that the Owlsmoor Park refurbishment will commence in May 2021.
